2. All UG/PG marks are not reflected in a single mark sheet, candidates are required to submit all original mark-sheets (individual semester/ annual).
3. Original document evidences of NET/NET-JRF (conducted by UGC/ CSIR/ DBT/ ICMR), GATE or INSPIRE Fellowship, National Fellowship for SC/ST, Maulana Azad Fellowship, National Fellowship for OBC candidates.

4. Original Category certificate (Gen-EWS/SC/ST/OBC/PwD etc.) in which the candidate has qualified NET/NET-JRF etc. The category shall be verified by scanning the QR code of NET/NET-JRF and other certificate as applicable.
5. Original University 1st Rank holder certificate in the concerned subject. (if applicable).
6. Conduct and College Leaving Certificate/Transfer Certificate.
7. Original Aadhaar Identity Card
8. Research Proposal/Write-Up of 2000 words.

The Research Proposal/ Write-up should include the following aspects.

- Title
 - A critical understanding of the body of knowledge in the subject area

 - Rationale of the study
 - Objectives of the study
 - Hypotheses/Research Questions
 - Methodology of work including Research Design, Population, Sample, Data Collection Process, Plan of analysis etc, as the case may be
 - Bibliography. (short)
