- (iii) She must not have taken C.L.C.
- (iv) The candidates who have completed the course by attending both theory and Practical Classes, thereby securing not less than 80% attendance in each theory paper (70% on production of Medical Certificate), and 90% in School internship Programme and have successfully completed the required number of Practical assignments (Task and Assignments, Practice Teaching etc.) duly assessed internally and fulfilling all other required conditions are to be declared eligible for the annual examination by the Coordinator / HOD of the B.Ed. Programme.
