## I. Eligibility of Regular Students

- (i) She must have taken admission to the +3 Ist Year Degree Course in Arts/Science/ Commerce (Hons / Pass) under (CBCS) pattern during the Academic year of 2022-23.
- (ii) She must have been admitted / Enrolled in the +3 Degree Ist Sem. (CBCS) Regular University Examination, 2022 as per the Regulation.
- (iii) She must not have taken C.L.C.
- (iv) The registered student of the University may be admitted to the +3 Degree 6<sup>th</sup> Semester (CBCS) Arts/Science/Commerce (Pass/Hons.) Regular University Examination,2025, if she has appeared/Enrolled in Ist Sem. (CBCS) Examination, 2022 in the concerned Stream and there after completed a regular Course of Study for not less than six months in the 3<sup>rd</sup> Year & 6<sup>th</sup> Sem. in one or more colleges for the purpose of such examination in the subjects which she offers, provided that she is not otherwise eligible to appear the said examination.
- (v) She must have obtained required percentage of attendance in conformity of the regulation.

### II. Eligibility of Students for Back /Improvement Examination.

- (a) She must have taken admission in the First Year +3 Degree Course under (CBCS) pattern in Arts/Science/Commerce (Pass/Hons)during Academic Year 2019-20,2020-21 & 2021-22 (Admission Batch).
- (b) She must have been admitted/enrolled to the +3 Ist Semester (CBCS) Regular Examination, 2019,2020 & 2021 Admission Batch.
- (c) She must not have taken CLC.
- (d) **Back Paper appearance**: A student has to clear back paper(s) (i.e. the paper paper(s) one has failed by appearing at subsequent semester examinations within six years from the Year/Session of admission.
  - If the candidate is Absent in any sitting(s) or Failed –("F" Grade), such a candidate shall have to reappear in that paper(s)/ Subjects in order to clear the back paper(s) to obtain required pass mark
- (e) The candidates are required to produce their Mark Sheet (Xerox copy) in case of Back paper appearance for verification to appear the 6<sup>th</sup> Semester (Back) Examination,2023.
- (f) A student may appear in improvement (having passed in that paper) in any number of papers ONLY ONCE in the next semester examination. There is no improvement in Practical papers.
