- +3 Degree 4th Semester Regular & Back Examination, 2025 (2019,2020,2021,2022 & 2023 AB)
- I. Eligibility criteria for Registration/Enrolment to the +3 4th Semester (CBCS) Regular Examination,2025 (2023Admission Batch)
 - (a) She must have taken admission to the +3 Ist Year Degree course under (CBCS) pattern in Arts/Science/Commerce (Pass/Hons) during the Academic year 2023-24.
 - (b) Any Registered students of the University may be admitted to the +3 Ist Semester (CBCS) Arts/Science/Commerce (Pass/Hons) Regular Examination,2023 in which she has undergone a regular (CBCS) course of study for not less than six months after passing the council of Higher Secondary Education, Odisha or any other equivalent Examination.

II. Eligibility criteria for Registration/Enrolment to the +3 4th Semester (CBCS) Back & Improvement University Examination, 2025 (2019, 2020, 2021 & 2022 Admission Batch)

- (a) She must have taken admission in the First Year +3 Degree Course under (CBCS) pattern in Arts/Science/Commerce (Pass/Hons) during Academic Year 2019-20,2020-21,2021-22 & 2022-23.
- (b) She must have been admitted/enrolled to the +3 Ist Semester (CBCS) Regular Examination, 2019-20, 2020-21, 2021-22 & 2022-23.
- (c) She must not have taken CLC.
- (d) Back Paper appearance: A student has to clear Back paper(s) (i.e. the paper / paper(s) one has failed, having secured grade 'F' by appearing at subsequent semester examinations within six years from the Year/Session of admission.

If the candidate is Absent in any sitting(s) or Failed –("F" Grade), such a candidate shall have to reappear in that paper(s)/ Subjects in order to clear the back paper(s) at least 'D' Grade.

If a student of 2019, 2020, 2021 and 2022 Adm. Batch is failed due to absent in Mid Sem. she will fill up the form for Back examination and appear the semester examination as per the schedule.

III. Assignment of Roll Number for Back Examination & Preparation of Alphabetical List.

(a) The Examination Roll number assigned to the Pass/Hons. candidates for Arts/Science/Commerce Examination at 1st Semester Examination, shall remain unchanged, if there is no discrepancies.

(b) Preparation of Alphabetical List:

The Alphabetical List shall be prepared Pass/Hons. wise for Arts/Science/Commerce without any mistake, containing Name of candidate, Examination Roll No. Registration Number, Subjects to be examined and care should be taken to indicate SC/ST/Disabled against each of their names for (Back) students separately.
