- (ii) Any registered student of the University may be admitted into the 2nd Yr. B.Ed. (Regular) Examination, 2025, if she has enrolled in the 2nd Yr. B.Ed. Course (Arts/Science), 2023,2022 & 2021.
- (iii) She must not have taken C.L.C.

(iv) REPEAT /BACK PAPER EXAMINATION

A candidate failing to secure 40 percent in any theory course(s) and 50 percent marks in any practical course(s) in the year end examination(s) shall be allowed to appear at examination in that course(s) as Back paper(s) and be given maximum three consecutive chances to pass in the concerned course(s). The internal marks secured by the candidate in that course(s) shall be retained as such.

The Examination Roll Number assigned to the candidate in Ist Yr. B.Ed. Examination shall remain unchanged and be prepared alphabetically stream-wise (Arts/ Science).
