Departments / College/Institution for their Enrolment to UG 4th semester Arts/Science/ Commerce (Major & Minor) **Regular Examination, 2026** as per the guidelines furnished below.

Tentative Date for the commencement of Regular Examination: 24.03.2026

I. Eligibility criteria for Registration/Enrolment to the UG 4th Semester (NEP) Regular Examination, 2026 (2024 Admission Batch).

- (a) She must have taken admission in the First Year +3 Degree Course under (NEP) pattern in Arts/Science/Commerce (Major & Minor) during Academic Year 2024-25.
- (b) Any Registered students of the University may be admitted to the +3 Ist Semester (NEP) Arts/Science/Commerce (Major & Minor) Regular Examination, 2024 in which she has undergone a regular course of study for not less than six months after passing the council of Higher Secondary Education, Odisha or any other equivalent Examination.
- (c) She must not have taken C.L.C.
- (d) She must have obtained required percentage of attendance in conformity of the regulation.

II. Mode of Form Fill up : ONLINE

The Examination Application Forms for UG 4th Semester Arts/Science/ Commerce (Major/Minor) Regular students shall be submitted through ONLINE.

III. Preparation of Alphabetical List of Regular Candidates

The Alphabetical List of Arts/Science/Commerce shall be prepared Major/Minor.wise separately containing names of candidate, Roll no., Registration No and Subjects to be examined and care should be taken to indicate SC/ST/Disabled etc. against each of their names for students separately . Students details should be uploaded online as per the schedule mentioned in **point V** in University website www.rduems.in positively.
