2. You are required to inspect the Institution established before 1982 and give your views on the reasonableness of fire safety arrangements. A copy should be given to the concerned authorities for compliance. Once they comply and fire safety arrangements are found to be reasonable and satisfactory, specific recommendation for grant of FSC may be made.

3. The institution is only exempt from Building Approval as it was established before 1982. Otherwise, the buildings require usual fire safety arrangements as applicable.

You are, therefore, requested to take necessary action accordingly.
