- 1. The Grant is for a period of one year from the date of issue of the letter.
- 2. Final report is to be submitted within the period of one year.
- 3. Please ensure that the final research report does not violate Copyrights / Intellectual Property Rights (IPR) of others and upholds academic integrity.
- **4.** Plagiarism is strictly prohibited as per the University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018.
- 5. The first instalment of the grant i.e. 40% of the sanctioned amount will be released after the applicant complies with the project grant initiation procedure.
- 6. After receiving the half yearly progress report, statement of expenditure and utilization certificate of the 1st instalment of the grant; the second instalment i.e. 40% of the total grant will be released.
- 7. The third and the final instalment i.e. 20% of the remaining amount will be released only after receiving the following:
 - Two hard copies of the final report along with the softcopy.
 - A consolidated item wise detailed statement of expenditure incurred during the entire duration of project in the prescribed format duly signed and sealed by the competent authorities of the university / college / institution and the Principal Investigator.
 - A consolidated Audited Utilization Certificate for the amount actually utilized towards the project duly signed and sealed by Govt. Internal Auditor / Chartered Accountant, competent authorities of the university / college / institution as well as the Principal Investigator in the prescribed format.
 - The unutilized grant (if any) may be refunded immediately through demand draft drawn in favour of Odisha State Open University, payable at Sambalpur.
