



ACADEMY-INDUSTRY INTERFACE:

Summer Internship Program (SIP) of total 28 students of RDWU MBA batch 2022-2024.

The Summer Internship Program (SIP) in MBA curriculum is an essential requirement that enables students to receive training from an industry of repute and contribute fruitfully towards the industry requirements in a small but effective manner. Moreover, it is mandatory under the university learning system. Based on our university course curriculum the students of MBA Second Semester are required to undergo Summer Internship Programme (SIP) for a period of 30 - 35 days starting from 20th May 2023 to 20th June 2023 or 24th June 2023. However, some of the organization started training in 12th May 2023 and 17th May 2023 based on their organizational guidelines. On successful completion of SIP they would likely obtain a certificate of completion from the interning organization. In the Third semester they would be required to submit a complete SIP report and give presentation before faculties and students for the semester evaluation.

So, in this regard, the Department of Business Administration has contacted the following list of organizations both online and offline mode as mentioned in the Annexure-I for SIP.
