## Proceedings of IQAC-Academic and Examination reforms committee meeting

A meeting of a sub-committee of IQAC for Academic and Examination reforms was held on 15.12.2021 at 04.00 pm in IQAC room under the Chairmanship of Prof. Sasmita Mohanty, CPGC, RDWU.

### Matters discussed and resolutions made:

At the outset Prof. Chandi Charan Rath, Director, IQAC apprised the members about the purpose of meeting. Prof Sasmita Mohanty, CPGC discussed about the Academic and Examination reforms with reference to UGC letter in RDWU. After thorough deliberation, following resolutions were made.

- 1. The existing P.G. Syllabus of the University would be reformed and the revised syllabus would be implemented from the academic session 2022-23. The revised syllabus would contain "Learning Outcomes" and "Transaction Mode" in each paper.
- 2. Two (02) courses from SWAYAM/NPTEL platform carrying 4 credits each would be incorporated in the P.G. syllabus to make 110 credits syllabus against the existing 102 credits. The said courses would be incorporated in Semester-II and III of P.G. syllabus respectively.
- 3. A common structure with paper codes to be prepared for the revised syllabus which would be approved in the Regulation Committee. Subsequently, all P.G. Departments would revise their existing syllabus. Finally, the syllabus would be placed to Board of Studies in the concerned subject for approval. IQAC would intimate the Regulation Committee accordingly.
- 4. There would be 05 units in each paper and each unit would carry 03 sub points in the revised syllabus.
- 5. Each Department would offer short term value added courses such as: One Certificate Course and one Skill Development Course from the session 2022-23.
- 6. Continuous and Comprehension Evaluation (CCE) approach would be followed for assessing the academic performance of P.G. students with effect from academic session 2022-23. The dimensions of such evaluation would be as follows:

a)	Mid-Sem Examination	20 marks	10 marks
b)	Quiz and/ or Assignment (for all subjects and all papers, except Dissertation and SWAYAM/NPTEL courses)	20 marks (assessment will be done for 40 marks and it will be converted to 20 marks)	10 marks (assessment will be done for 20 marks and it will be converted to 10 marks)
c)	End Sem Exam	60 marks	30 marks
