Rama Devi Women's University, Bhubaneswar, Odisha established in 2015 by an Act of State Legislature of Odisha as a State University (hereinafter referred as "RDWU") is the only Women's University of the state empowered to award degrees as specified by the UGC The university has its own departments, its constituent College and affiliated Women Colleges. The University is taking the leading role in women education in the state

Whereas

RDWU and SNPMT have agreed that for encouragement and development of cooperation and exchange in areas of mutual academic interest, it is desirable to enhance educational cooperation at both the organizations, RDWU and SNPMT do hereby enter into this memorandum of understanding for academic and educational cooperation and have set forth the following terms on Mutual Agreement.

- RDWU and SNPMT will work together for academic development of the students studying all disciplines of plant sciences through academic feedback, guidance and exposure of students to the contemporary fields of research in different branches of plant sciences.
- 2. Department of Life Sciences, RDWU be the nodal department to work together with the trust for formulation and execution of the academic cooperation between RDWU and SNPMT.
- 3. The Department of Life Sciences, RDWU shall arrange academic enrichment programmes from time to time for the students of the department as well as of other sister departments through the support of SNPMT.
- 4. Department of Life Sciences RDWU will organize an annual lecture named "Prof. S. N. Patnaik Memorial Lecture" ordinarily in the month of September by inviting a Scientist/ Research of national/ International repute, who has made significant contribution to Plant Sciences. The speaker will be decided mutually by the governing body of the trust and RDWU.
- 5. SNPMT will provide financial support for organizing the annual lecture and other activities in RDWU to meet the cost towards the arrangements of the events without any financial implications to RDWU.
- 6. RDWU will provide the logistic support to organize the lecture. RDWU will allow all bona fide students, research scholars and faculty in the field of Plant Sciences of other organizations to attend the lecture.
- 7. Both the organization will work together, through their representatives to formulate academic cooperation for the benefit of students.
