(d)Ex-officio	Head of College Development Council
(e)Ex-officio	Head of Students Welfare
(f)Ex-officio	Head of Human Resources Development Centre or its equivalent body (Not Applicable)
(g)Ex-officio	Regional Director of Education of Higher Education Department
(h)	Three Professors of the University nominated by the Chancellor on Seniority-cum Rotation basis
(i)	Three Principals or Professors of Government Colleges, affiliated to the concerned University nominated by the Chancellor on Seniority-cum-Rotation basis
(j)	Two members of the Academic Council elected by the Council thereof
(k)	Three Principals of non-Government Aided Colleges, affiliated to the University, nominated by the Chancellor
(l)	Three eminent persons in the field of education, academics, research, corporate industries or public administration nominated by the Chancellor
(m)	Three eminent persons in the field of education, academics, research, corporate industries or public administration nominated by the State Government
(n)	One representative of the non-teaching employees of the concerned University to be nominated by the Vice-Chancellor (Not Applicable)

N. B.: The Sub-section (f) & (n) of Section (10) (1) are not applicable presently because there are no such positions created for Sub-Clause (f) and no one qualifies for the position under Sub-Section (n)

Section (10) (2): The term of office of the members, other than ex-officio members shall be of four years.

(a) Ex-Officio	Vice-Chancellor of the concerned University
(b) Ex- Officio	Director Higher Education
(g) Ex- Officio	Chairman, PG Council
(h)	All the heads of Departments of the Post Graduate and Under Graduate subjects of the University and the Constituent Colleges including the Principals of the constituent colleges <u>The Principals of Constituent Colleges of the University</u> – Not applicable to RDWU as it has no constituent colleges at present.
(i)	Ten heads of Departments of the Post Graduate subjects of affiliated colleges, not below the rank of Associate Professor/Reader, to be nominated by the Vice-Chancellor.
(j)	Principals of not more than one-third the number of affiliated colleges of the University, subject to a maximum of twenty, as may be nominated by the Chancellor keeping in view the representation of the Districts, institutions for women, minorities, professional subjects and Post Graduate Studies and the Non-Government Colleges.
(k)	Two persons of Academic eminence nominated by the Chancellor.
(l)	Not more than ten teachers of Colleges within the jurisdiction of the concerned University as may be co-opted as members by the Academic Council so as to secure such representation of different branches of learning as such Council may consider adequate (No members are nominated to this section at present)
(m)	Librarian of the University
(n)	the Officer-in-charge of students welfare of the University
