The National Mission on Education through Information and Communication Technology (NMEICT) has been envisaged as a Central Sector Scheme to leverage the potential of ICT, in teaching and learning process for the benefit of all the learners in Higher Education Institutions in any time anywhere mode. NMEICT Scheme has been extended till 2025-26. This includes various digital initiatives like SWAYAM, SWAYAM Prabha, National Digital Library, Virtual Lab, SAMARTH-ERP etc. for the benefit of students and for support of educational institutions for better governance.

2. Academic Bank of Credit (ABC), as envisaged in the NEP-2020, is a National-level facility to promote flexibility of curriculum framework and interdisciplinary multidisciplinary academic mobility of students across the Higher Education Institutions in the country with appropriate "Credit Transfer" mechanism.

The major functions of ABC are registration of HEIs under the ABC scheme and, opening, closure and validation of academic accounts of students, credit verification, credit accumulation, credit transfer redemption of students and also promotion of the ABC amongst the stake holders. ABC, by itself, is not a degree-awarding organization and is part of the Digilocker ecosystem.

3. University of Delhi is the Implementing Agency of the SAMARTH Project under NMEICT Phase-III Scheme of Ministry of Education. It is being implemented in 47 Central Universities, 32 NITs, 25 IIITs, 20 IIMs, IGNOU and manages over 7.1 Millions students' records. A total 50- HEIs and 20 TEQIP Institutions have also been on boarded on the SAMARTH e-Gov Suite in SAAS model. SAMARTH ERP suite covers the entire student lifecycle from admissions to degree.

4. With the growth in digital education in higher education segment, ABC and SAMARTH are expected to provide scaffoldings to the administrative & governance paradigm of the future.

5. You may have already implemented an eGov or ERP suite at your universities. However, it is worth highlighting that some of the functionality of SAMARTH – such as integration with ABC, Fee management, are customized to the needs of state run institutions and you may want to evaluate some of this functions to be integrated through an API integration. In this regard, you may inform all Institutes/HEIs/Universities/Autonomous Colleges in your state to evaluate functionality of SAMARTH eGov suite and adopt as per their requirements.
