

Sir,

This is to bring to your kind notice that teachers and non-teaching staff of Rama Devi Women's University, Bhubaneswar are facing acute problem in getting rented accommodation in Bhubaneswar at a price range equal to their house rent allowance. The University, being a new University established in 2015, does not have residential facilities of its own for its employees. This educational institution was a Government college till 2015 before it was upgraded to University. When it was a Government college, the teachers and other staff of the college were being allotted with Government quarters by the GA Department from the pool of GA Department quarters available in Bhubaneswar. But this facility has been stopped after the institution was upgraded to a University.

The letter of Registrar of RD Women's University addressed to the undersigned with a copy to Director of Estates-cum-Additional Secretary, GA & PG Department is enclosed herewith wherein the university has made a request for allotment/earmarking of 28 GA Department pool quarters located in Unit IX in favour of the university. These identified quarters are located near the university and are currently lying vacant.

It is, therefore, requested to kindly allot the identified Government quarters under GA Department pool in favour of the university for use by its teachers and other non-teaching staff. Moreover, as a permanent measure, it is also requested to kindly hand over about 100 (Hundred) Government quarters located near the university to the university on a permanent basis.

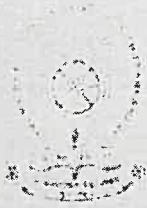

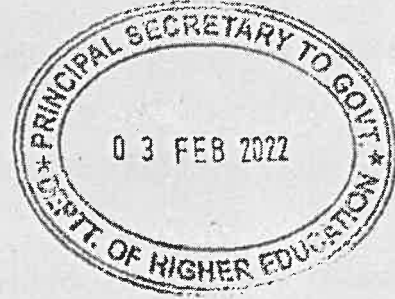

Sir,

In inviting a reference to the subject cited above. I am directed to inform you that Rama Devi Women's University has no facilities for accommodation of the University staff and several faculty have made a representation for allotment of residential quarters (Letters attached). The lack of residential quarters imposes financial burden to the staff as they pay house rent that is 4-6 times more compared to the HRA that they are currently availing. Recently, one of the faculty selected through OPSC has been unable to find any rental accommodation due to discrimination by house owners on the basis of his regional and religious identity (Letter attached). In continuation with previous requests referenced above, to earmark Government quarters in and around Unit-IX to the University staff, I am to bring to your kind attention that several quarters in the area are currently vacant and maybe allotted to the teaching and non-teaching staff. The details of the quarters and suggested University staff is as follows:
