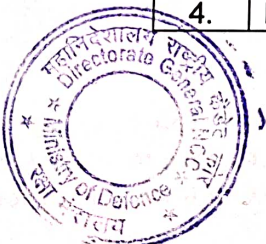
**NCC CADETS DELEGATION TO NEPAL UNDER

4. Nominated cadets will report on **25 Feb 2024 (F/N)** at DG NCC Camp, Delhi Cantt and will finally be returned to their respective Dtes on **18 Mar 2024 (A/N)**. Cadets are also advised to get the return journey reservations made for **18 Mar 2024 (A/N)**. These dates are tentative in nature.

5. Girl/Boy cadets will be escorted by a GCI/Lady ANO escorts on both, to and fro journeys to / from Delhi and thus train reservations for GCIs/Lady ANO escorts may also be done accordingly.

6. It must be ensured that for the visa purpose, the passport of nominated cadets should be valid format least 06 months from the date of initiation of journey.

7. **Contribution by Directorates.**

(a) **Uniforms and Dress.** Rs.7940/- per cadet towards kitting, memento and extra messing charges will be carried in Cash. The cadet will bring this amount in cash. The Directorates will ensure that the cadets are in possession of following items when they report at New Delhi:-

(b) **Out of Pocket Allowance.** Each cadet is paid US\$10 per day. Thus, present conversion rate of INR is Rs 83/ US \$. Each cadet will carry Rs. 9,960/- (Rupees Nine Thousand Nine Hundred Sixty Only). The amount should be transferred to the account of cadets. This amount will be reimbursed to all dtes after culmination of the visit. In this regard please read policy letter No. 4406/PA/DGNCC/TRG/YEP dated 30 Nov 2021. The Directorates will ensure that the cadets are in possession of following items when they report at New Delhi:-

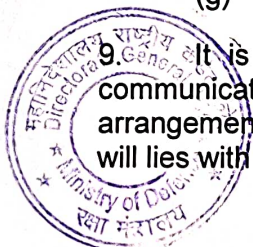
- (i) Bank Details of Directorate/Gp HQ/ Bn/ Unit through which the payment to the cadet has been made.
- (ii) Cancelled copy of Cheque of Directorate/Gp HQ/ Bn/ Unit though which the payment to the cadet has been made.

8. The following documents in triplicate (in A4 size paper) are required to be forwarded by the Directorates through the cadets and also send via email to GSO-1 Trg (YEP): -

- (a) Bio-data with colour photograph.
- (b) Willingness Certificate.
- (c) Medical Certificate.
- (d) Indemnity Bond.
- (e) Passport and photocopy.
- (f) Four Passport size photographs in civil clothes.
- (g) Eating habits Veg / Non Veg.
- (h) Blood Group.
- (j) Full Vaccination Report.
- (g) Size Roll.

It is requested that the availability of the cadets and passport details may please be communicated at the earliest (by email or on telephone) to enable us to make pre departure arrangements with concerned Ministry, airlines and others. Responsibilities of obtaining passport will lies with cadets / respective Dtes.

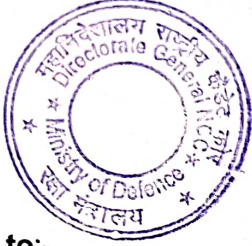


