

The office is responsible for end to end process of the students' assessment and works in close collaboration with institutions and individuals.

2. <u>Perspective Plan</u>

(a) Short Term

- To conduct the Final year Semester Examination and Back Examination for the final year and pass out students through offline as per the programme notified.
- ➤ To conduct of Examination Committee meeting, BOS meeting and meeting of Board of Conducting Examiners through offline.
- To conduct Pre-thesis Presentation & Viva Voce Presentation for Ph.D. Scholars.
- > To design common question paper format for all programmes.

(b) Long Term

- ➤ To conduct the Semester Examination and Mid-Sem. Examination.
- ➤ Planning to complement Question bank for all programmes
- ➤ To conduct the Examination as per the New Education Policy (NEP) 2020.

3. Academic Calendar

For every academic year the schedule of both Odd & Even semester Examinations are notified through academic Calendar. Detailed calendar for both UG, PG and B.Ed. Examination is prepared by the Examination Section and displayed in the University website.

4. Meeting for Board of Studies

Meeting of Board of Studies of all the departments were organized for structuring, revision and approval of Syllabus. Meetings for different departments were organized between 25th August, 2020 to 27th August 2020 for the academic session 2020-21. The Board recommended the list of the Paper Setters, Examiners and the Moderators for the academic year 2020-21.

5. Examination Committee Meeting

In the academic year 2020-21, 05 (five) no. of Examination Committee meetings were held on different dates. Meetings were held on 29.06.21, 09.04.21, 01.03.21, 04.09.20 and 20.08.20. Details of the discussion made in the meetings are given in Annexure-IV.

6. <u>Setting of Question Papers</u>

The question papers for the End Semester Examinations are set to ensure full coverage of the syllabus as per the weightage of the modules of the concerned clause units: The questions are framed in such a way that the student Learning Outcomes are properly assumed and weightage given to each module of instruction is properly reflected in question. To ensure outcome-based education, the questions are set by experienced and trained teachers and also moderated by moderators as recommended by the Board of Studies.

7. Conduct of Examinations

(a) Examination Notification for UG

For the academic year 2020-21, odd semester examination were conducted from 2nd week of January,2020 to 3rd week of April,2021. Even semester examination for UG programme held from 3rd week of September.2020 to 3rd week of April,2021 for final year students. The back examination for final year students & passed out students was conducted from 15th May 2021 to 24th May 2021. Detailed examination programme was notified nearby 30 days before the commencement of examinations.

(b) Examination Notification for PG

For the academic year 2020-21, 3rd semester examination was conducted on 27.03.2021 in online mode. 4th semester examination conducted on 21.09.2020. 2nd semester (Back) examination was conducted on 25.09.2020

(c) Appointment of Observers/Squad

For transparency in the conduct of Examination, different nodal centres were selected by the approval of Examination Committee and the Vice Chancellor. Besides this, semesterwise a team of squad members were appointed by the University for inspection of different Examination Centres.

(d) While conducting the examinations, all COVID-19 preventive measures such as social distancing, hand washing, sanitization, compulsory use of mask, routine disinfection were taken.

8. Evaluation of Answer Booklets

Valuation for UG Programme is carried out Zone wise for which 4 to 5 no of Zones are selected as recommended by Examination Committee and approved by Vice Chancellor. On the other hand evaluation of Answer Scripts for P.G., & B.Ed. is carried out by Home Valuation process.

9. **Board of Conducting Examiners**

Recommendations of the Board of Conducting Examiners, results of different programmes were published within 40 days from the last date of Examinations. The meeting of Board of Conducting Examiners to pass the final result of UG on 27th July 2020 and PG & M.Phil exam was held on 13th August 2020. The students pass percentage was mentioned in Annexure-V.

10. Grievance of Students

(a) Re-addition

During the session 2020-21, 143 UG student shad applied for readdition of marks, out of which mark of 13(thirteen) students was revised. Mark of 02 (two) PG students out of 09 (nine) was changed. No revision of marks was required for M.Phil students who had applied for the same. The list is attached in Annexure-VI.

11. Automation in Examination System

In the examination section, the following processes were automated:

- Online Examination Application form generation and payment of Examination fee
- Nominal Roll generation
 Examination Timetable for CIA and CE
- Regular and Arrear Examination online Hall ticket generation
- Result processing and publishing the results
- SGPA and CGPA calculation
- Mark sheet generation for Semester, Provisional and Consolidated sheets
- Convocation list and Rank list generation

12. Security features Involved in Examination Section

- ❖ Controller Section module is enabled only for few users in the application, only the Authorized users have access to the module. If some other user tries to access the module, an error 'Unauthorized Access' will get displayed.
- Screens like Mark Sheet generation, Consolidated Mark sheets, and Provisional Certificate generation can only be done by a few users and the screen is enabled only from their Machine IPs. If the same user tries to get access from other Machines, then the screen will not get displayed.
- ❖ The entries made by one user cannot be edited / deleted by other users. If any changes are made in the mark sheet, then mark sheet approval screen will be used by the Controller of Examinations to check whether the changes made are brought to the notice and the reason for the edit is captured for future reference.

13. National Academic Depository and Academic Bank of Credit

As per UGC's communication, it is mandatory to digitalize student's academic awards (degrees, diplomas, certificates, mark sheets) and store them in the National Academic Depository (NAD) which is an online storehouse of academic awards. NAD is a 24 X 7 online mode for making available academic awards and shall help in validating their authenticity, their safe storage, and easy retrieval. UGC has also requested all the Central and Deemed Universities to establish NAD Cell and enter into a Service Level Agreement (SLA) as early as possible with either of its two interoperable digital depositories namely, NSDL for utilizing services of NAD. Our Institute agreed with CDSL. Validation of academic records in the NAD will be primarily on the strength of this agreement. We have uploaded 209461 marks sheets in NAD portal for academic session 2015-2023.

To operationalize NAD, RDWU registered itself with digilocker on 25 March 2021. As of 2023, the University is also registered under ABC for enabling smoother credit transfers.

14. <u>Issue of Transcript, genuineness of documents</u>

On receipt of application from students, the University issued 07 (seven) no. of transcripts and 01(one) no. of Genuineness Certificate. Annexure-VII

A meeting of the Examination Committee was held on dt. 04.09.2020 in order to discuss some important matters related to the Final Semester/Term Examination, 2020. The following members were present in the Examination Committee meeting:

Resolutions

- The Committee decided to adopt and implement the revised guidelines issued by the UGC (vide No.19181 Dt. 07.07.2020), DHE vide letter No. 28335 Dt.02.09.2020 on the issue of the conduct of Final Semester/Term examination of UG/PG/B.Ed. 2020.
- In view of the Covid-19 situation, it was resolved that the examination shall be conducted in both online and offline modes in two sittings each of 1 hour duration with 40/30 marks for non-practical & practical Subjects respectively. Students can opt for any one mode of examinations.
- It was further decided that the examination programme shall also contain the component of 'Assignment Mode' for some papers as per rules.
- Conducting of examination shall be completed between 20th and 30th September, 2020 and the
 results shall be declared by 31st October, 2020. The question pattern shall be descriptive in
 nature, covering all the units of the paper.
- The Examination for two Theory Papers (UG/PG) shall be held in one day in two sittings each of one hour duration, observing the Covid-19 SOP implementation strategy.
- The examination for the remaining Theory Paper(s) (UG/PG/B.Ed) shall be conducted in the 'Assignment Mode' to avoid overstay of the students appearing in the offline mode.
- 7. The question paper for the 'Assignment Mode' of examination shall be supplied by the University and the evaluation shall be done by the faculty members of the nearby colleges. In case of non-availability of external faculty, the evaluation shall be done by the internal faculty of the examination centre.
- All Back Paper examinations of UG/PG/B.Ed (Theory/Practical) shall be conducted in the 'Assignment Mode' as these candidates have appeared at their final examination earlier.
- 9. The Practical Examination of 1 hour duration shall be conducted both in the online/offline modes. Question papers for the Practical Examination shall be supplied by the University. The viva-voce of the Practical Examinations shall be conducted online (Whatsapp/ Skype/other meeting apps etc.) / offline. The Answer scripts of the Practical Examination shall be collected in the online/offline mode like the theory papers.

Based on the continuous problems faced from the NIC related to Examination works and as per the advice of the Hon'ble Vice Chancellor, two numbers of firms having experience in Exam Works such as: (1) M/s COEMPT Edu Teck Pvt. Ltd., Hyderabad, (2) M/s DATATECH, Bhubaneswar had been invited for discussion. The said two firms presented their proposals and credentials.

After deliberations on various aspects the following extracts were made based on their proposals with reference to the examination requirements at RDWU.

(1) M/s COEMPT Edu Teck Pvt. Ltd., Hyderabad

- a) This firm has experience of exam works in Ravenshaw University and BPUT in Odisha. It works online with automation process.
- b) The budgetary estimation includes purchase of software for Pre and Post Examination- Rs. 40 Lakh (which includes One year warranty, one time installation and training of staff, one year remote online support).
- c) It includes, AMC (taxes extra) after expiry of warranty period, and Accommodation cost of the visiting staff.
- d) AMC is 20% of the total cost of the product (10% increases after expiry of each AMC period). It includes onsite support (twice a year with each 5 days of stay) and online support on all working days from 10:00 am to 4:00 pm.

(2) M/s DATATECH, Bhubaneswar

- a) This firm has experience of Exam works in North Orissa University, Fakir Mohan University, Shri Jagannath Sanskrit University, SCS Auto. College, Dhenkanal Auto. College etc. in Odisha. It works with semi-automation process.
- a) Its Financial Implication includes:

Annual Maintenance Charge : Rs. 50,000/- (each year).

Pre and Post Exam Processing : Rs. 23/- per candidate per exam.
