The office of the Controller of Examinations, ensures transparency in all its activities like Conduct of Examination, Valuation, Publication of Result, with the aim to support faculty, students and Institution.

The office is responsible for end to end process of the students' assessment and works in close collaboration with institutions and individuals.

2. Perspective Plan

(a) Short Term

- Conducted the Final year Semester Examination and Back Examination for the final year and pass out students through offline as per the programme notified.
- Conduct of Examination Committee meeting and meeting of Board of Conducting Examination through offline.
- Conduct of Pre thesis Presentation & Viva Voce Presentation for Ph.D. Scholars.
- Common question paper format for all programmes.

(b) Long Term

- Planning to conduct the Semester Examination and Mid-Sem. Examination.
- Planning to complement Question bank for all programmes to conduct the Examination as per the New Education Policy (NEP) 2020.

3. Academic Calendar

For every academic year the schedule of both Odd & Even semester Examinations are notified through academic Calendar. Detailed calendar for both UG, PG and B.Ed. Examination is prepared by the Examination Section and displayed in the University website. Calendar of events for UG Programme is attached in Annexure-I and calendar of events for PG Programme is attached in Annexure-II.

4. Induction Programme

An induction programme was conducted at the beginning of the academic year for the students admitted in 2021-22 on 10th January 2022. During the programme the students were appraised of all the matters related to examinations like Choice Based Credit System (CBCS) of learning, attendance norm, midterm examination, minimum marks for passing, Grading system, award of Gold medal & Distinction, the grace period for course completion. The students also appraised of regarding an appeal for transparency, revaluation, readdition and availability of other facilities.

5. Meeting of Board of Studies

Meeting of Board of Studies of all the departments were organized for structuring, revision and approval of Syllabus. Meetings for different departments were organized between 13th May 2021 to 15th May 2021 for the academic session 2021-22. The Board recommended the list of the Paper Setters, Examiners and the Moderators for the academic year 2021-22.

6. Examination Committee Meeting

In the academic year 2021-22, **10** Examination Committee meetings were held on 20.07.2021,06.08.2021,04.09.2021,18.10.2021,28.10,2021,30.10.2021,08.02.2022,16.03.2022, 06.05.2022 .

A virtual meeting with the Examination Committee of RDWU was held on 29.06.2021.

Details of the discussion made in the meetings are given in Annexure-III.

7. Setting of Question Papers

The question papers for the End Semester Examinations were set to ensure full coverage of the syllabus as per the weightage up the modules of the concerned clause units : The questions are framed in such a way that the student Learning Outcomes are properly assume and weightage given to each module of instruction is properly reflected in question. To ensure the outcome based education, the questions set by experienced and trained teachers are moderated by moderators as recommended by the Board of Studies.

8. Conduct of Examinations

(a) Examination Notification for UG

For the academic year 2021-22, odd semester examination were conducted from last week of December, 2021 to March, 2022. Even semester examination for UG programme was held in April, 2022. Detailed examination programme was notified nearby 30 days before the commencement of examinations.

(b) Examination Notification for PG

For the academic year 2021-22, odd semester examination were conducted from last week of December, 2021 to March, 2022. Even semester examination for UG programme were held in April, 2022.

(c) Examination Notification for B.Ed.

For the academic year 2021-22, odd semester examination were conducted from Last week of December, 2021 to March, 2022. Even semester examination for UG programme held in April, 2022 for final year students.

(d) **Appointment of Observers/Squad**

For transparency in conduct of Examination different nodal centres are selected by the approval of Examination Committee and the Vice Chancellor. Besides this semester wise a team of squad members are appointed by the University for inspection of different Examination Centres.

(e) All theory papers of +3 3rd Semester (Regular) Examination,2020 was held in online mode due to COVID-19 Pandemic.

9. Template of Final Certificate for U.G. /P.G.

The template of final certificate for UG and PG students was placed on 08.02.2022. The selected template has all the necessary security features. The Odia typing of the certificate was done under the supervision of the Odia department of the University to expedite the process and a deadline of 20th March 2022 was fixed for the completion of the certificate data.

10. Evaluation of Answer Booklets

Valuation for UG Programme is carried out Zone wise for which 4 to 5 no of Zones are selected as recommended by Examination Committee & approved by Vice Chancellor. On the other hand Answer Booklets for P.G., B.Ed. & Ph.D. Programme is carried out by Home Valuation process.

11. Board of Conducting Examiners

Recommendation of the Board of Conducting Examiners, results of different programmes were published with 40 days from the last date of Examinations. The meeting of Board of Conducting Examiners to pass the final result of 2022 was held on 16.08.2022. The students pass percentage is mentioned in Annexure-IV

During pandemic, results of 4th semester (Regular) was published by Alternative Evaluation Method.

12. Grievance of Students

(a) Re-addition

A total no of 57 students had applied for readdition of different papers who had appeared in the examination held in the academic session 2021-2022 with the prescribed fees. Out of 47 students, marks of 05 (five) students were revised. The list of students whose marks have been changed is attached in Annexure-V

13. Automation in Examination System

In the examination section, the following processes were automated:

- Online Examination Application form generation and payment of Examination fee
- Nominal Roll generation
- Examination Timetable for CIA and CE
- Regular and Arrear Examination online Hall ticket generation
- Result processing and publishing the results
- SGPA and CGPA calculation
- Mark sheet generation for Semester, Provisional and Consolidated sheets
- Convocation list and Rank list generation

14. Security features Involved in Examination Section

- ❖ Controller Section module is enabled only for few users in the application, only the Authorized users have access to the module. If some other user tries to access the module, an error 'Unauthorized Access' will get displayed.
- ❖ Screens like Mark Sheet generation, Consolidated Mark sheets, and Provisional Certificate generation can only be done by a few users and the screen is enabled only from their Machine IPs. If the same user tries to get access from other Machines, then the screen will not get displayed.
- ❖ The entries made by one user cannot be edited / deleted by other users. If any changes are made in the mark sheet, then mark sheet approval screen will be used by the Controller of Examinations to check whether the changes made are brought to the notice and the reason for the edit is captured for future reference.

15. National Academic Depository

As per UGC's communication, it is mandatory to digitalize student's academic awards (degrees, diplomas, certificates, mark sheets) and store them in the National Academic Depository (NAD) which is an online storehouse of academic awards. NAD is a 24 X 7 online mode for making available academic awards and shall help in validating their authenticity, their safe storage, and easy retrieval. UGC has also requested all the Central and Deemed Universities to establish NAD Cell and enter into a Service Level Agreement (SLA) as early as possible with either of its two interoperable digital depositories namely, NSDL for utilizing services of NAD. Our Institute agreed with CDSL. Validation of academic records in the NAD will be primarily on the strength of this agreement.

16. Certificate Distribution Ceremony

A certificate distribution ceremony was held on 21st June, 2022 since convocation could not be held on account of COVID pandemic. Certificates were given to 24000 students for 48 affiliated colleges of the University for UG 2016,2017,2018 Admission Batch, P.G 2017,2018,2019 Admission Batch, B.Ed. 2017,2018,2019 Admission Batch & M.Phil. 2018,2019 Admission Batch.

17. Issue of Transcript, genuineness of documents and duplicate certificates

On receipt of application from students, the University issued 06 (six) no. of duplicate Mark Sheets and Provisional Certificates, 07 (seven) no. of transcripts and 21(twenty one) no. of Genuineness Certificates. Annexure-VI

18. Skill based Certificate Course

A skill-based certificate course was introduced for PG students of 2022 Admission Batch. Certificate were distributed to all students who completed the course.







The details of alternative evaluation method was finalized as follows :

Internal evaluation shall be based on the mark secured by the student in Mid-Sem. of the semester concerned.

Alternative Evaluation Method (AEM) for UG 4th Semester (2019 Admission Batch)

- **For Arts/Science/Commerce (Hons & Pass)** students mark secured in End semester of SEC-I shall be posted as End Sem. mark SEC-II.
- Similarly mark secured in End Semester of GE-B-I will be reflected in GE-B-II and mark secured in GE-III paper will be posted as End Semester mark of GE-IV.
- Average of End Semester marks secured in core papers in previous Semester will be posted as the End Semester mark for core papers.
- e.g. Average of C-V, C-VI, C-VII (3rd Semester) will be posted as End Semester mark of C-VIII, C-IX, C-X (4th Semester)
- **For Commerce (Hons)**, in C-IX, which is a Paper with Practical, marks in Theory (End Sem-60) & Practical (Full Mark=25) will be given by the proportionate calculation from the average of the three core papers i.e. C-V, C-VI, C-VII.
- **For Arts (Pass) students**, mark secured in End Semester of DSC -1C, DSC -2C will be reflected as the End Sem. mark of DSC -1D & DSC -2D respectively.
- **For Science Pass** mark secured in DSC -1C, DSC -2C & DSC -3C will be posted as the End Sem. mark for DSC -1D, DSC -2D & DSC -3D respectively.
- **For compulsory papers in Arts (Pass)** mark secured in End Semester of English-I for 3rd semester will be posted in English-II for 4th semester Examination, 2021 (2019 Admission batch).


