CHAPTER - 1

INTRODUCTION TO THE ETHICS AUDIT

Introduction

Ethics refers to the guidelines for conduct that address questions of morality. Ethics determine what is right. It is a system of moral principles. It also tells what is morally correct or incorrect, in the given situation. The knowledge transformation in an ethical manner is a key consideration. The ethics audit is a tool to measure the effectiveness of ethics education as evinced in the policies, processes, and programs of the organization in which the student may work. Akin to an ethics audit, it provides a rubric for assessing an organization's ethics related compliance, and its elements are a useful teaching tool in the classroom to focus the impact of ethics in decision-making on the organizational ethics values. Designed for assessment across sectors, the ethics audit instrument introduced here provides a common framework that allows for consensus in education, training, and organizational policy, as well as in ethics and legal code development. University internal ethics context are those factors that stimulate the faculty, staff administration, students including the stakeholders to behave ethically. The internal ethics audit contains both formal and informal parts.

The formal part consists of the different measures and Activities University has undertaken within its academic year to stimulate ethical behavior. Hence, programmes and activities to make aware about university code of ethics, training in ethics, an ethics office(r), and a whistleblowing policy. In view of this the ethics audit examined the quality and effectiveness of such a program. The ethics audit committee also examined other elements of the ethics such as the procedures, policies, systems, and rules (so-called hard- controls), curricular to evaluate whether they absorb the ethical risks an organization faces and whether they stimulate managers and employees to behave ethically.

Objectives of Ethics Audit

The main purpose of conducting annual ethics audit of Rama Devi Women's University is to examine the perception and attitudes of the university stakeholders towards the goal of the University from integration of ethics and values perspectives. Following is a set of specific objectives:

- To conduct an ethics audit of the university to understand the present status of the integration of ethics and values perspectives.
- To explore the promotional strategies undertaken by the University both in the curricular and extracurricular areas to address the ethics and values related issues.
- To examine the level of awareness about the university code of conduct, national days
 of importance and students engagement in the ethics and values towards community.
- To recommend strategies to strengthen the ethics and values in all key areas of the university activities.

Ethics audit assed the steps taken descriptions and corresponding pictures about the hygiene, health and safety measures, waste management practices in the university campus, zero food wastage, no substance abuse or alcohol consumption, compassionate and empathetic towards students coming from poor economic condition and backward region and students with disabilities. In the hostel or for any campus services or construction work no to child labor practices, including maintaining working hours and equal wages for both male and female, representation of students in various committee and class, disciplinary practices, and zero tolerance to gender discrimination at the workplace.

CHAPTER - 2

METHODS OF DATA COLLECTION AND ANALYSIS

In view of the ethical audit to be conducted by the committee members a survey questionnaire has been designed. A structured questionnaire has been designed and Liket scale has been used to collect information.

The questionnaire has been converted into online google format and has been circulated among the faculty members and staffs for the year 2018-19, 2019-20, 2020-21, 2021-22 and 2022-23. The ethical audit report has been prepared by the ethical committee members based on the responses of the faculty, staffs and students about their understanding and day today practices. Descriptive statics has been used for analysing the data and information. Next section presents the questionnaire survey and various responses expected from the respondent.

In the year 2018-19 a hard copy of the questionnaire has been circulated among the university employees to assess the ethics and values orientations. Ethical Audit Committee sends a set of questionnaires available in the Google form and requested to the respondents to submit the same within a timeline. The valuable inputs greatly contributed to complete the online data collection. Confidentiality has been maintained against the name and valuable inputs. However, the concern of the respondents was analysed and interpreted in the ethical audit report. Further, the committee have conducted personal open-ended discussion and discussion with the key informants. Group discussion and brainstorming exercises were conducted among the ethical audit members.

Next section discusses the result of the data analysis and illustrates the descriptive data through bar diagram and pie chart. The interpretation of the statistical diagrams is informed next to each of the figures respectively.

The formal part consists of the different measures and Activities University has undertaken within its academic year to stimulate ethical behavior. Recommendations 2018-19

- 4. The committee analysed the survey responses and presented in its ethics report. Discussed about the difficulties of few faculty members about their understanding on the set of questionnaires.
- 5. The committee resolved that from next years a simplification version of the questionnaires shall be designed to receive a greater number of responses.
