






Audit Report of Persons with Disability

Rama Devi Women's University is committed to empower women through education as is engraved in the Institute's Vision and Mission and ensures ample opportunities for women students from all sections (culture, region, language, caste, socio-economic status and students with special needs) without any discrimination. The inclusive climate of the University is reflected in all its academic and administrative activities paving way for an integrated campus community. Being the premium woman institute in the vicinity of Odisha' capital, it has been considered as one of the safest places attracting disable girl students from all over the State. More than fifty students with different types of disability including three teachers throw light on the inclusive practices of the University.

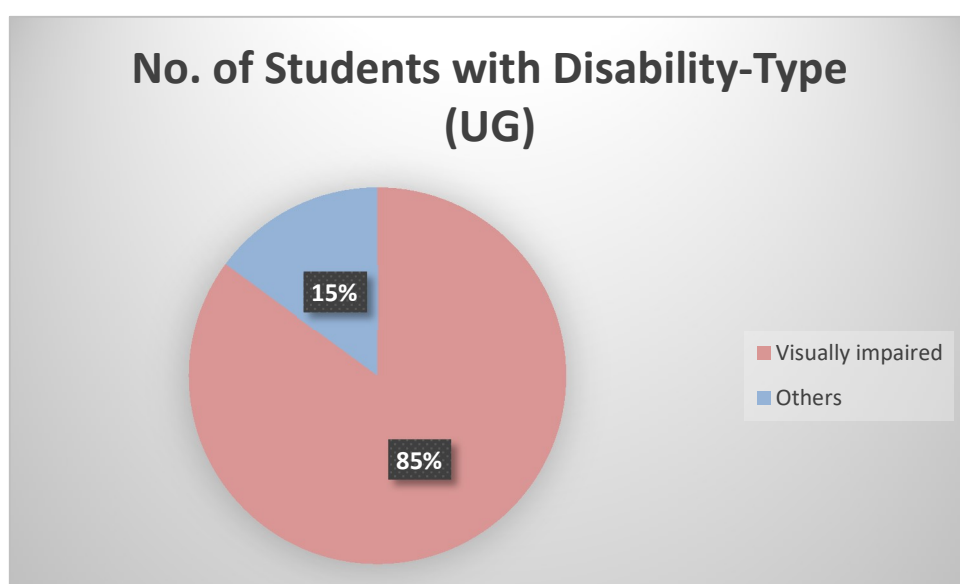


Figure-1 : No. of students with Disability-Type (UG)

Out of 94 disable students taken admission in UG program, eighty students i.e. 85% are visually impaired and 14 number of students i.e. 15% suffer from physical disability.

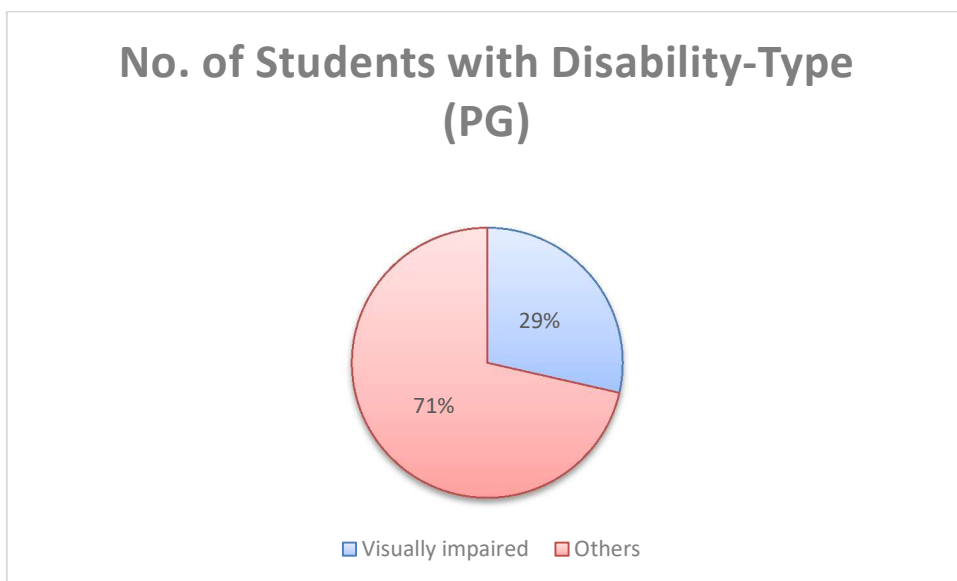


Figure-2 : No. of students with Disability-Type (PG)

Out of 07 disable students taken admission in PG program during 2021-23, 02 students are visually impaired and 05 students suffer from physical disability.

Among the teaching staffs, one teacher is visually impaired, one teacher is having physical disability and one teacher suffer from hearing impairment. One office assistant (non-teaching) suffer from physical disability.

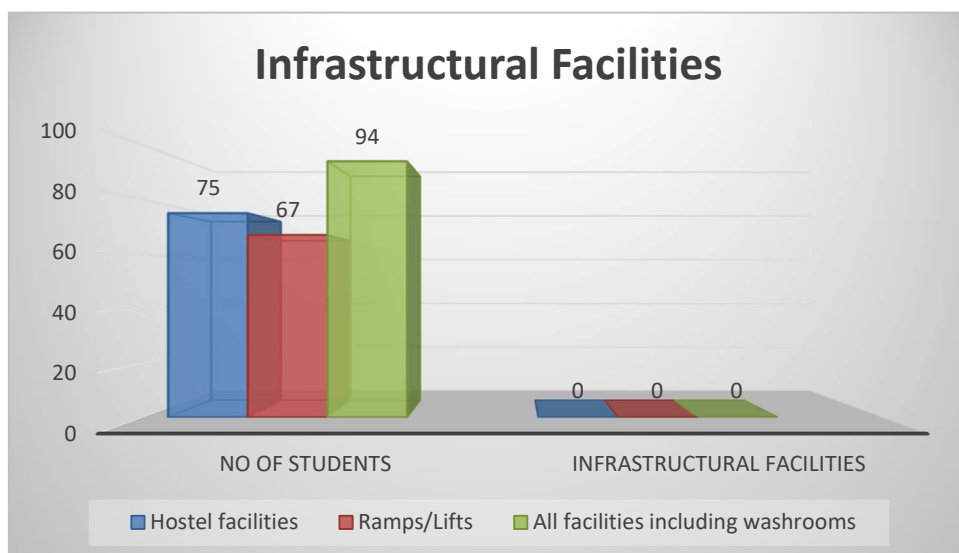


Figure-3 : Infrastructural Facilities availed by the disable students.

Regarding the availability of various facilities, 75 students have reported about availability of adequate hostel facility, 67 students are using ramps and lifts, and 94 students are availing all infrastructural facilities including disable friendly washrooms in the University. All the teachers reported about the non-availability of accommodation facility inside the campus.

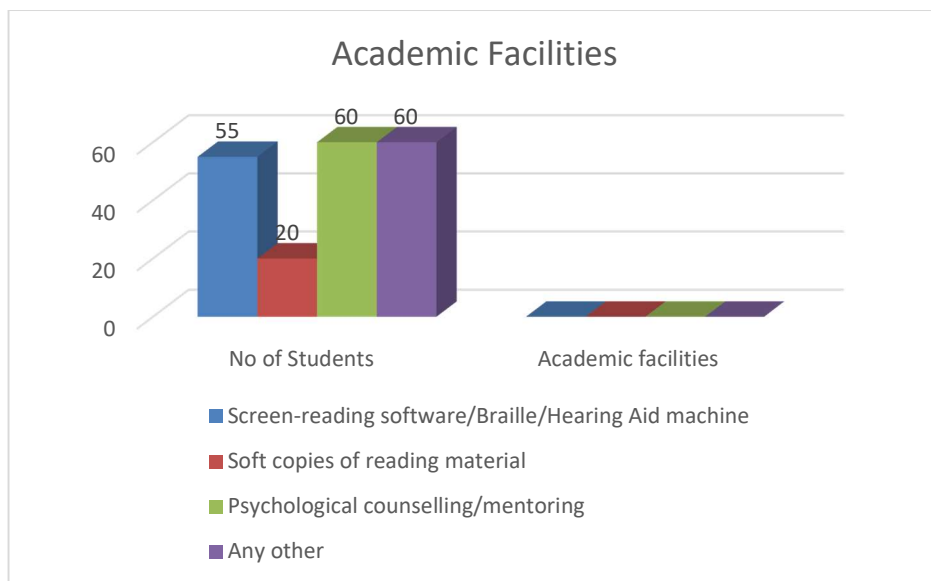


Figure-3 : Academic Facilities availed by the disable students.

Based on the feedback of students, it is concluded that maximum number of students i.e, 60 are attending mentoring/counselling classes on a regular basis and availing other reading materials. 20 Students suffering from physical disability are availing soft copies of reading materials. Many students expressed their ignorance about the availability of various soft wares for visually impaired students in the library.

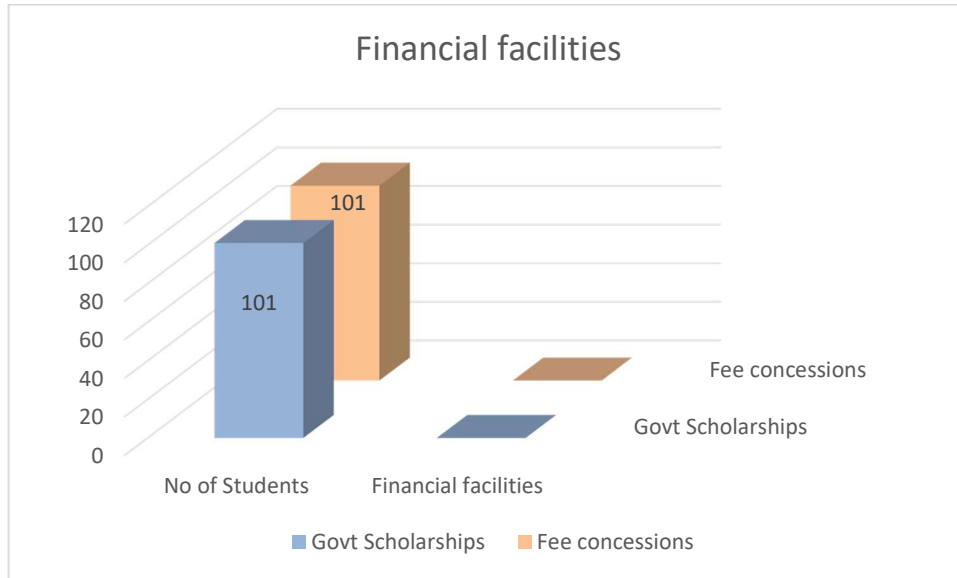


Figure-4 : Financial Facilities availed by the disable students.

All students i.e. 101 avail both institutional and Govt. scholarship. Students are also getting fee concessions in terms of admission, accommodation etc. However, students staying in hostel demand for more financial support from the Govt. to meet their day to day expenses in hostel.

Suggestions and Recommendations

On the basis of analysis of suggestions given by 46 PwD students and 3 staff members, the Committee recommended the following:

1. Construction of Ramp with Hand rails in all the blocks including Central Library and Administrative block as well.
2. Lift facility in all the blocks to support disabled students. Steps may be taken to build lift/ramps in University hostel
3. Separate bathrooms for PWD to be made in all the buildings.
4. Provision for regular Scribes to meet the needs of various examinations.
5. Audio Books, Digital Audio Recorder etc. for Visually Impaired Students.
6. Provision for adequate Video and Audio facility in class rooms.
7. Shifting the Library to the ground floor for easy access.
8. Automatic Vehicle/ Scooter and Wheel Chair facility to help them roam around indepartment


and in the University.

9. Separate cultural events giving scope for participation of such students need to be organised.
10. Provision for training on dance, song etc. as per the interest and ability of students.
11. Recording of all study materials for the convenience of Visually impaired students

Besides the suggestions given by students with disability, the committee recommends the following for betterment of life of such students in the University campus.

1. To establish a Disabled Support Centre to identify the needs of such students.
2. A University level Co-ordinator may be appointed to identify the needs and grievances of such students and to give suggestive measures for betterment of their learning conditions inside the University campus.
3. Transportation facilities may be provided to nearby areas for easy movement of students from their home to institution.
4. Residential facility may be increased to accommodate all PwD students in the campus.
5. Self-defence sessions need to be organised by collaborating with Govt./NGOs.
6. PwD friendly competitions and programmes may be organised to enhance the confidence level of students.
7. Tie up with Govt. to get free Laptop, Digital Audio-Recorder and other study related materials.
