# NOTIFICATION

The 7<sup>th</sup> meeting of the Syndicate of Rama Devi Women's University was held on 23.04.2018 at 11.30 A.M. in the University Conference Hall and was chaired by the Vice-Chancellor Prof. (Dr.) Padamaja Mishra. The Items discussed were resolved as follows: ITEM- 01.

Ratification of the corrigendum No. Esstt/Rect-2018/793 dated 09.02.2018

### Resolution:

The approval of publication of one corrigendum of advertisement No. Esstt/ Rect-2018/644 dated 02.02.2018 as per the UGC guidelines in all news papers except the New Indian Express vide notification No. Esstt/ Rect-2018/793 dated 09.02.2018 was ratified.

### ITEM- 02.

Ratification of the Constitution of the Scrutiny Committee for Recruitment of Professor, Associate Professor, Assistant Professor.

### Resolution:

The approval of constitution of the Scrutiny Committee for recruitment of Professor, Associate Professor and Assistant Professor in response to the Advt. No-Estt/Rect-2018/644 dt. 02.02.2018 vide O.O. No-1886/dt.06.04.2018, 1993/dt. 13.04.2018 & 2131/ dt.20.04.2018 was ratified.

### ITEM- 03.

Considering the constitution of the Selection Committee for the Recruitment of the Professor, Associate professor, Assistant Professor

### Resolution:

The constitution of Selection Committee for the recruitment of Professors, Asso. Professors and Asst. Professors in response to the Advt. No-Estt/ Rect-2018/644 dated 02.02.2018 as per the OUA 1989 21(3) and Correction slip No.14 dated 04.12.2002 including the members from ST/SC/PwD/ Minority community & HOD in the committee was approved. In case of absence of HOD or in the department having co-ordinator, the Chairman, P.G. Council would be the member of the committee.

#### ITEM- 04.

Considering the Allowances, Lodging, Boarding and other hospitalities for the Selection Committee Members.

#### Resolution:

The proposal for consideration of the Allowances, Lodging, Boarding and other hospitalities for the Selection Committee Members as per rule was approved as

i) Travelling allowances to the Outside Members

To and fro economy class Air-fare or Train fare as per rule.

ii) <u>Conveyance to the local members</u>

To and fro taxi fare from residence to University as per rule.

iii) <u>Conveyance Allowance to Outside Members</u>

To and fro conveyance allowance from residence to station/port and port/station to University/ Guest House/ Hotel as per rule.

iv) Sitting Allowance

Rs 2000/- (Rupees two thousand) per day for experts only.

v) No allowances for the Rama Devi Women's University Members.
In case of non availability or non-suitability of the State Guest House, the local accommodation and hospitality is to be made in the other Guest Houses/Hotels as per availability.

### ITEM- 05.

Considering the procedure of calling for interview.

## Resolution:

The following procedure of calling for interview was approved.

After recommendation of the Scrutiny Committee, the eligible candidates may be intimated through the SMS with regard to the date and timing of the interview and intimation letter is to be issued to the candidates at least 15 days before of the scheduled date of interview through speed post/Registered post.

- The selection committee for any post (Professor/Associate Professor/Assistant Professor) of any department will be called, only if there are at least two applicants found to have met the minimum eligibility criteria for the said post.
- The eligibility criteria as laid down by UGC Regulations 2010 and subsequent amendments up to 4<sup>th</sup> amendment of 2016 from time to time are to be followed.

### ITEM- 06.

Evaluation of the candidates' Performances & Appointments

# Resolution:

It was resolved that the Evaluation of the candidates performances is to be done as per the guidelines laid down in the correction slip no.12 of the OUFS 1990 statute no 258 "SCHEDULE"A" and also considering the weightage given to Educational Carrier , Research, Teaching Skills and Interview performance as laid down in the UGC (4<sup>th</sup> Amendment) Regulations,2016. Taking all these rules, the Evaluation format was approved. The three (03) subject experts have to give marks on publications and Interview performances of the candidates. A proposal was moved by Dr. Durga Shankar Sarangi to authorise the Vice-Chancellor to take decision with regard to the eligibility criteria, procedure of sending call letters, selection of subject experts, scrutinization & evaluation of candidates Career & performance and sending appointment letters to selected candidates, allowing the selected candidates to join the post. This was duly seconded by the esteemed member Dr. Gopinath Kar and the Syndicate unanimously agreed to the proposal moved by Dr. Sarangi. It was resolved that the decisions taken with regard to the appointment and joining of candidates taken by the Vice-Chancellor without prior approval of the Syndicate will placed before the next Syndicate meeting for ratification.
