NOTIFICATION

Dr. Heeramani Beura, Principal, Tulasi Women's College,Kendrapada, 6. Dr. Durgasankar Sarangi, HoD, Economics. The items discussed were resolved as follows:

- 1. Approval of the proceeding of the selection committee for the post of Professors, Associate Professors & Assistant Professors of different subjects for which selection committee has met till date.**

In Pursuance of this office Advt. No. Estt.I/Rect/2018/644 dt. 02.02.2018, the selection committee for the post of Professors, Associate Professors & Assistant Professors of Home science, Odia, Gender Studies, Education and Economics, Commerce met in different dates from 05.06.2018 to 18.07.2018. 
