NOTIFICATION

The 10th Meeting of Syndicate was held at 11.30 a.m. on 04.08.2018 .The meeting was chaired by the Vice-Chancellor, Prof. (Dr.) Padmaja Mishra and attended by 1. Padmashree (Smt) Prativa Roy, Chancellors Nominee, 2. Dr. Sitanshu Kumar Dash, Chairperson, P.G. Council, 3. Dr. Heeramani Beura, Principal, Tulasi Women's College, Kendrapada, 4. Dr. Durgasankar Sarangi, HoD, Economics. The items discussed were resolved as follows:

1. Ratification the vice –chancellor's order to postpone the interview for the post of the Professor, Associate Professor and Assistant Professor of Business Administration, Hindi in view of Government of Odisha, Department of Higher Education letter no. 20978 dt.24.7.2018 .

In Pursuance of this office Advt. No. Estt.I/Rect/2018/644 dt. 02.02.2018, the interview by the selection committee for the post of Professors, Associate Professors & Assistant Professors of Bio-Technology, Life Science, Computer Science, Home science, Odia, Gender Studies, Education, English and Economics, Commerce, Journalism and Mass Communication (11 subjects) have been completed by 25.07.2018. On 25.07.2018 by 5.45 p.m., a letter bearing no 20978 dated 24.7.2018 from Govt. of Odisha, Higher Education Department was received with regard to postponement of the process of Teachers if it is already underway, till further orders. The vice- chancellor on dated 25.07.2018 ordered (Annexure -1) ordered to send information of postponement of interview to the candidate called for interview in the subjects of Business Administration scheduled on 27th, 28th & 29th 2018 and Hindi on 3rd August, 2018. All the candidates were informed through SMS and e-mail on same evening.

Resolution: The order of the Vice- Chancellor to postpone the interview of Business Administration and Journalism & Mass Communication in view of Govt's letter has been ratified.

2. Considering the further action on the Proceedings of the Selection Committee for the post of the Professor, Associate Professor and Assistant Professor of Journalism & Mass Communication held on 25.07.2018 in view of Government of Odisha, Department of Higher Education letter no. 20978 dt.24.7.2018.

In Pursuance of this office Advt. No. Estt.I/Rect/2018/644 dt. 02.02.2018, the selection committee for the post of Professors, Associate Professors & Assistant Professors of Journalism and Mass Communication met on 25.07.2018. On 25.07.2018 by 5.45 p.m., a letter bearing no 20978 dated 24.7.2018 from Govt. of Odisha, Higher Education Department was received with regard to postponement of the process of Teachers if it is already underway, till

further orders. The proceedings of the selection Committee for the post of Professors, Associate Professors & Assistant Professors of Journalism and Mass Communication is in the closed envelop till date in view of Govt. of Odisha, Higher Education Department letter no.20978 dated 24.7.2018.

Resolution: The Proceeding of the selection committee for the post of Professor, Associate Professor & Assistant Professor of Journalism & Mass Communication held on 25.07.2018 is to be kept in the sealed cover in view of Govt's letter until final order from UGC and/or Govt. of Odisha.

3. Ratification of the order of the Vice-chancellor on 26.07.2017 to keep on hold the appointment and joining of the selected candidates of Odia, Education, Economics and Commerce who have not joined till date in view of Government of Odisha, Department of Higher Education letter no. 20978 dt.24.7.2018 until further order.

The appointment letters for the post of Professors, Associate Professors & Assistant Professors of Odia, Education, Economics and Commerce subjects were sent to the selected candidates on 10.07.2018, 10.7.2018, 20.07.2018, 20.07.2018 respectively. 09 selected candidates whom the appointment letters was issued (Odia-one professor(UR), Education- one Associate Professor(UR), One Asst. Professor(UR), One Asst. Professor(SC), Economics-one professor(UR), One Asso.Prof (UR), Commerce- One Asso. Professor(UR), One Asst. Professor(UR), One Asst. Professor(ST)) could not join their posts. The Vice-Chancellor ordered on 26.07.2017 to keep the joining of these 09 on hold till further order in view of Government of Odisha, Department of Higher Education letter no. 20978 dt.24.7.2018. The SMS and e-mail were sent to 06 candidates and 03 candidates received hard copy as they came to the university to join their posts on 26.07.2018.

Resolution: The order of the Vice-chancellor on 26.07.2017 to keep on hold the appointment and joining of the selected candidates of Odia, Education, Economics and Commerce who have not joined till date in view of Government of Odisha, Department of Higher Education letter no. 20978 dt.24.7.2018 until further order is ratified.

4. Ratification of the Vice-chancellor's order on 26.07.2018 to allow conditional joining of Dr. Aparajita Biswal as Associate professor of Economics, Dr. Sabat Kumar Digal as Associate Professor of Commerce on 26.07.2018 FN.

Dr. Aparajita Biswal, selected for the post of Asso. Prof. of economics, Dr. Sabat Kumar Digal selected for the post of Asso. Prof. of Commerce, being relieved from their posts from Utkal University came in the forenoon to this University to join their posts. When they received, the "Kept on hold" letter in view of Government of Odisha, Department of Higher Education letter no. 20978 dt.24.7.2018, they requested the vice-chancellor to allow them to join as they have already been relieved by the Utkal University. Keeping their request in view, the Vice-chancellor ordered to allow conditional joining subject to final order of the UGC and/or Government of Odisha. They were allowed to join their posts provisionally w.e.f 26.07.2018 FN Vide this office order no 4104 dated 3.8.2018 and 4106 dated 3.8.2018.

Dr. J. Jesthy, selected for the post Asst. Prof. of Commerce reported for joining on 26.07.2018 after receiving the "Kept on hold" without being relieved from the present Posting. Her application has not been considered so far.

Resolution: The Vice-chancellor's order on 26.07.2018 to allow conditional joining of Dr. Aparajita Biswal as Associate professor of Economics, Dr. Sabat Kumar Digal as Associate Professor of Commerce on 26.07.2018 FN is ratified. There would be no further conditional joining of the selected candidates until further order.

5. Approval of list of appointment letters issued, joining order issued, order of keeping on hold of joining till 03.08.2018.

The detail (list enclosed) of action taken with regard to appointment, joining, postponement of interview, keeping hold of the joining till 03.08.2018 is placed here with consideration.

Resolution: The List of posts, persons selected, appointment letters issued, joining order issued, order of keeping on hold of joining till 03.08.2018 as shown is approved.

Other matters, if any:

Dr. Sitanshu Dash, P.G. Council Chairperson moved a proposal with regard to invitation of applications for admission into MBA and Journalism & Mass Communication subjects for the session 2018-19 as there was no advertisement in view of non- completion of the teachers' recruitment. In view of postponement of recruitment process as per Government of Odisha, Department of Higher Education letter no. 20978 dt.24.7.2018 until further order, he sought views of members in this regard. The members discussed the matter threadbare.

Resolution: The members unanimously agreed to open both the subjects from this session and to manage the teachings through the appointment of guest faculties till recruitment of the regular teachers.
