NOTIFICATION

The 18th meeting of Syndicate of the University was held on 06.11.2019 at 12 O'clock in the University Conference Hall under the chairmanship of Hon'ble Vice-Chancellor Prof. (Dr.)Padmaja Mishra. The items discussed were resolved as follows:

ITEM-01

To consider the ratification of Vice Chancellor's approval on temporary engagement of DharitriMallick as Computer Programmer on payment of remuneration of Rs. 20,000/- per month and temporary engagement of AnkitaBiswal as IT instructor /trainer on payment of remuneration of Rs. 12,000/- per month.

DharitriMallick and AnkitaBiswal have been temporary engaged as Computer programmer and IT instructor/ trainer vide notification No- 3595 dated 18.09.2019 and No- 3598 dated 18.09.2019 respectively under the approval of Vice Chancellor on 17.09.2019.

Resolution: The approval of the Vice Chancellor on temporary engagement of Dharitri Mallick as Computer Programmer on payment of remuneration of Rs. 20,000/-per month and temporary engagement of Ankita Biswal as IT instructor /trainer on payment of remuneration of Rs. 12,000/- per month was ratified.

ITEM-02

To consider ratification of approval of Vice Chancellor on supply of 06 nos. of manpower service to Asima Hostel.

Sealed tenders were invited from the registered manpower agency to provide the service of 06 nos of personnel on contractual basis for day to day work at Asima Hostel vide letter No-3438/dt. 07.09.2019. In response 13 nos agencies/ firms submitted tender papers. The purchase committee at its meeting held on 23.09.2019 unanimously approved M/S R. R Enterprises as the L 1 firm. Accordingly work order was placed in favour of M/S R. R Enterprises for supplies of 06 nos of different personnel on contractual basis for day to day work at Asima Hostel vide order No-3857/dt.01.10.2019.

Resolution:The approval of the Vice Chancellor on supply of 06 nos. of manpower service to Asima Hostel was ratified.

The Interview committee recommended the selection of the following candidates to be engaged in Department of Biotechnology, Life Science & Computer Science respectively:

- 1) Monika Behera Department of Biotechnology.
- 2) Sahani Begum Department of Life Science.
- 3) Sarmistha Nanda Department of Computer Science.

These recommended names were approved by the Vice-Chancellor on 09.08.2019 & 31.08.2019.

The said candidates are joining as Project Assistant in the respective departments as mentioned above with a monthly fellowship of Rs.22, 000/- (Consolidated) for 03 years or until completion of project whichever is earlier on contractual and co-terminus basis as per the terms and conditions laid down by the funding agency.

Resolution: The Vice- Chancellor's approval on the appointment of above mentioned Project Assistant (03 Nos) under CURIE Programme of this University was ratified.
