### NOTIFICATION

The 21<sup>st</sup> meeting of Syndicate of the University was held on 15.05.2020 at 11.00 A.M. in the chamber of Vice Chancellor under the chairmanship of Hon'ble Vice-Chancellor Prof. (Dr.)Padmaja Mishra. The items discussed were resolved as follows:

#### ITEM-01

Ratification of Vice Chancellor's decision for allowing the Professor / Associate Professor / Assistant Professors to join the University and to consider for sending the appointment letter to the next selected candidates in the panel in case of non-joining of the candidates.

#### Note

Pursuant to decision of Syndicate in the meeting held on 01.02.2020, item No. 1 and subsequent approval of Vice Chancellor, the appointment letters of the following selected candidates in different subjects were sent.

- i) Sl. No.4 & 6 have joined the University and their joining have been accepted.
- ii) Sl. No. 1,2,3, have applied for extension, but their request for that were not accepted and communicated to them vide this office letter No. 1190 Dt.11.03.2020, No.1212 Dt.11.03.2020 and No.1210 Dt. 11.03.2020 respectively. After that they have neither communicated anything to the University nor joined the post on or before the last date of joining. Sl. No. 3 applied for extension of date of joining through e-mail on 22.04.2020 which was not accepted by the University vide approval of Vice Chancellor on

05.05.2020. The same has been communicated to him on 11.05.2020 through e-mail.

- iii) Sl. No. 5 & 7 have neither communicated anything to the University nor joined the post on or before the last date of joining
- iv) There is no other selected candidates in the panel for the posts of Prof. of Economics and Odia besides Sl 1 & 2 respectively.

**Resolution:** The decision of the Vice Chancellor in allowing Sl. 4 & 6 of the above list for joining is ratified. However, in view of instructions of Higher Education Department with regard to on going Lockdown and representation of some of the above selected candidates it is resolved that the joining time of 1,2,3,5 & 7 is to be extended till 31.05.2020.

**ITEM-02**

To ratify the Vice Chancellor's decision for allowing the selected candidates for the post of Assistant Professor in Journalism and Mass Communication and to consider to send appointment letter to the next selected candidates under same category in the same panel in case of non-joining of the candidates.

Sl. No. 1 & 3 have joined and their joining was approved by the Vice Chancellor on 07.03.2020 & 19.03.2020 respectively

Sl. No. 2 has neither joined nor communicated the University about his intention of joining.

**ITEM-03**

To consider the name of the Syndicate nominee in the Selection Committee for selection of the next Vice Chancellor of the University.

**Note**

As per the letter from Chancellor's office vide No. 3851 dt.01.05.2020 the tenure of the incumbent Vice Chancellor of the University ends on 14.07.2020. For selection of next Vice Chancellor, the Chancellor's office vide its letter No.3731 dt,27.04.2020 has requested the University to propose the name of the Syndicate nominee who shall be a member of the Selection Committee for selection of the new Vice Chancellor of the University.

**Resolution:** Resolved that the Registrar to communicate the nominee of the Syndicate ( in a sealed cover)for the Selection Committee for selection of the new Vice Chancellor of the University.

**ITEM-04**

To consider the extension of supply of Manpower Services to the University by M/s Kalinga Warriors & Security Services from 01.05.2020.

Vide this office order No.4866 dt.06.09.2018, M/s Kalinga Warriors & Security Services was requested to supply Manpower Services of different categories to the University from **01.09.2018 to 31.03.2019** which was subsequently extended from **01.04.2019 to 30.09.2019** vide its order No.1534 dt.10.04.2019 and again from **01.10.2019 to 31.03.2020** vide its order No.3495 dt.11.09.2019 and again from **01.04.2020 to 30.04.2020** vide its order No.1462 dt.21.04.2020.

**Resolution:** In view of Lockdown, the tenure of M/S Kalinga Warriors & Security Services was extended for supply Manpower Services to the University for 3 months from 01.05.2020 or finalisation of new Tender for that whichever is earlier.
