Following syndicate approval for installation of 500 KVA transformer of Academic Block at an estimated cost of Rs. 15,12,479 and resolution to assign the work to OPHWC, the University vide Letter no 2485 Dt. 17.07.2020 asked OPHWC to submit a DPR for undertaking the project. OPWHC vide Letter No. 8229 Dt. 30.07.2020 submitted a revised estimate of Rs. 18,39,695/- and requested administrative approval of the same.
- 2. As the estimate submitted by OPHWC was considerably higher than the approved estimate, University vide Letter no 2909 Dt. 22.09.2020 sought permission from Dept. of Higher Education to request accordance of permission to use balance fund out of Rs. 6 crores sanctioned under the head of infrastructure development grant for the installation of 500 KVA transformer.
- 3. Govt. vide its Letter No. 2745, Dt. 19.02.2021 has accorded permission for the use of balance fund for this purpose.

#### ITEM-10

To consider the approval of estimated cost of Rs.20,99,520/- per annum for cleaning of

As per the syndicate approval, Govt. gave permission to float fresh tender to hire

(Old Academic, New Academic Library, Administrative Buildings, Illostel) and campus by Jament of Agency through tender

However, out of remaining 04 categories, 02 nos. of computer programmer hiring is under way. The hiring of security officer (01), System manager (01) and Gardener (01) is yet to be done.

To consider for approval of estimated cost of Rs. 14,82,378/- per annum for engagement of Securities at Gate, Old Academic Building, New Administrative Building, New Academic Building, Library Building and New Hostel Building.

Resolution: The estimated cost of Rs. 14, 82,377.52/- per annum for security provision in the building & campus for the year 2020-21 by Agency through tender process is approved.

As approved by the Syndicate, 13 nos of Securities are currently engaged.

### ITEM -13

To consider the proposal of giving work order in favour of OPHWC of Rs. 3.37crore for internal roads in the campus.

Resolution: The decision of Govt. to give all Civil & Electrical works of the University to the OPHWC is approved and also approved the decision of the University in allotting work of internal Road construction of Rs. 3,37,95,217/-in favour of OPHWC.

Following Syndicate approval of University decision to allot OPHWC the work of internal road construction at the cost of Rs. 3,37,95,217/- the University vide Letter No 2014 Dt. 10.06.2020 asked OPHWC to submit a DPR for undertaking the work.

Post submission of DPR by OPHWC, the University gave administrative approval and expenditure sanction for the work to OPHWC vide Letter No 2707 Dt. 20.08.2020.

The University released Rs. 1,11,52,252/- (COF Office Order No. 2801 Dt. 2.09.2020) in favour of OPWHC for construction of

The work is presently ongoing in the University campus.
